## **TREASURER'S REPORT PERIOD ENDING 30 JUNE 2022**

### Financial Presentation of these Accounts

The society reports its results using the Accruals reporting method. The reporting standard adopted is as advised by the Charities Commission and is in compliance with the Statement of Recommended Practice 2015 (SORP 2015).

The Society was registered as a Charitable Incorporated Organisation ("CIO") with the Charity Commission on 15 June 2017 as charity number 1173438.

A summary of the accounts is presented below.

### Total Funds

The society's funds increased to £17,482. Included in this is an accrual for interest of £76 due from the Redwood Bank ("Redwood") and an accrual for HMRC gift aid claim of £104. The Redwood interest will be paid on 16 December 2022 and the HMRC gift aid claim was submitted to HMRC on 03/07/21 and paid to the CIO bank account on 07/07/21.

### Income

Subscriptions were £490 (£460 last year).

The Redwood account is a 95-day notice account with interest at 1.35% pa as of the end of the year (rates rose during the year). Interest is paid into the account annually on 16 December. Interest of £76 has been accrued in the accounts representing the interest earned from 16/12/21 to 30/6/22, the end of the CIO financial year.

Gift aid of £104 was paid by HMRC to the society's account on 7 July 2021.

### Expenditure

There was £118 of expenditure recorded in this financial year (last year £74) as follows:

Please note there has been some additional expense to the above incurred by the officers and the Trustees of the RPS (paper and printing, stamps, letters, envelopes, mileage and similar). The amounts are small and have not been claimed.

#### Other Financial matters

The financial statements have been reviewed by Rupert Edwards FCA. Rupert has certified that the accounts are in accordance with the notes and records of the society.

No payments have been made to any Trustees or to officers other than payment of £16.78 to Alastair Fisher as reimbursement of the first item listed above, and £66.07 to Nigel Williams as reimbursement of the second item listed above. All society bank accounts whether operated electronically or by letter require 2 authorised signatures for any amount.

There are no off-balance sheet items in the Society's affairs or accounts.


No person or body holds any mortgage, lien or charge over the Society's assets.
